HIGHLIGHT OF ACCOMPLISHMENTS

- Promoted to the academic rank of Professor July 1999.
- Conducted the boll weevil monitoring and eradication program in Eddy, Chaves, and Lea counties. Facilitated the formation of the eradication committee. Received grant funding for this project.
- Conducted the pink boll worm monitoring program; permanent cotton plow down date's state wide.
- Responded to catastrophic losses due to flooding in Eddy County, assisting the vector control unit in developing a disaster response plan, and assisting agriculture disaster programs.
- Responded to catastrophic losses of cotton on 42 different farms in Malaga. Identified the cause of the losses, worked with the New Mexico Congressional delegation to get two million dollars restitution for the farmer from the United States Government. The lengthy report was read into the Congressional Record.
- Promoted range land health by working with the Bureau of land management, Soil and Water Conservation Districts, Natural Conservation service and Extension Specialist, since 1999 over 300,000 acres have been strategically treated for Mixed brush removal.
- Promoted noxious weed management by working with the Bureau of Land Management noxious weed specialist developed a Memorandum of Understanding with 28 different federal, state, and local agencies participating for controlling noxious weeds.
- Conducted public information meeting and facilitated the formulation of the Pecos river native vegetation restoration project. Resulted in over five million dollars for control of salt cedar along both the Pecos and Rio Grande rivers.
- Instrumental in the establishment of the Lower Pecos Water user's organization to develop regional water plan. Resulted in the three volume publication and adaptation of the plan by the Inter State Stream commission.
- One of the objective of the water plan was better watershed management, facilitated

the formation of the Pecos watershed management association, which is made up of federal, State, and local government agencies as well as private individuals.

- Encouraged the formation of the Carlsbad, and Artesia anti-drug and gang collations.
- I have written over 650 newspaper articles since 1999 through a weekly column published in 4 newspapers.
- I have appeared in over 200 local television education programs. One program on African bees has run numerous times on the discovery channel with national distribution.
- Have conducted over five hundred one hour radio programs.
- Identified and made recommendation on losses of cattle on 49 different ranches. Often serving as mediator between agencies, corporations, and ranchers.
- Identified and assisted farmers losses from cut worm which destroyed over 500 acres in Eddy county, was designated a natural disaster by the Eddy County Commission, the Governor of New Mexico, the Secretary of the United States Department of Agriculture. After appeal, scientific evidence presented the famers received disaster payments.
- Appointed to the Agriculture water conservation task force by the Governor of New Mexico, severed for six years.
- Appointed to the New Mexico Behavioral Health Council by two different Governors of New Mexico, selected as parliamentarian, and re-wrote the constitution, by-laws, standard operation procedures. Serving for twelve years.
- Received funding through CDBG, and New Mexico State Legislature combined was over 2 million dollars for updating equipment for the De Baca General Hospital.
- Assisted the Eddy County Manager in securing from New Mexico State Legislature funding to build the Eddy County Community Building at the Eddy County Fair Grounds.
